Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.

- 4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
- 5. Incubate all tubes and plate at 30°C for 24 to 48 hours.

Notes

In broth, growth is turbid with a flocculent to viscid sediment. Vegetative cells are motile, Gram-positive rods. Many oval spores are formed.
