Medium: ATCC Medium 44: Brain Heart Infusion Agar/Broth ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood Temperature: 37°C Atmosphere: Aerobic

### Handling Procedures

- 1. Open vial according to enclosed instructions.
- Using a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for 24 to 48 hours.

This strain is cited to produce restriction endonuclease *Nsu*I (Nucleic Acids Res 13, 1985).
