Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #44 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #44 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.
3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.

4. Incubate at 37°C for 24-48 hours in an atmosphere of 5% CO₂.

Notes

The depositor states that even on primary isolation, cultures are in the non-smooth phase and do not possess A and M antigens of smooth *Brucellae*. Strain is not lysed by *Brucella* phage Tb.

Different species of blood may be used. Depositor recommended 10% defibrinated horse blood. We have used both rabbit and sheep blood with success.

If growth does not appear on primary agar plate or slants, transfer again from the 48 hour broth culture. This strain requires 5% CO₂ for growth.
