*Vibrio vulnificus* strain 324 was isolated from human blood in Florida. This whole-genome sequenced product produces hemolysins and has applications in waterborne pathogen research and as a control strain for the detection of *Vibrio vulnificus*.

### **Handling Procedures**

1. Open vial according to enclosed instructions.
2. Using a single tube of #2 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0

- mL with a Pasteur or 1.0 mL pipette and use to rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a second tube of broth, an agar slant and/or plate.
  5. Incubate the tubes and plate for 24 to 48 hours at 30°C.
