# Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the entire pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
- 4. Use several drops of this suspension to inoculate an additional broth tube, a

#18 agar slant and/or a plate.

5. Incubate the tubes and plate at 37°C for 24 hours.

#### Notes

Colonies on #18 plates are entire, glistening, circular, smooth, convex, and opaque. On sheep blood agar plates it produces  $\beta$ -hemolysis.

This strain is the recommended host for *Staphylococcus aureus* bacteriophage CDC 47, ATCC<sup>®</sup> 27691-B1™.
