Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. Use several drops of this suspension to inoculate an additional broth tube, a

- #18 agar slant and/or a plate.
5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

Colonies on #18 plates are entire, glistening, circular, smooth, convex, and opaque. On sheep blood agar plates it produces β -hemolysis.

This strain is the recommended host for *Staphylococcus aureus* bacteriophage CDC 47, ATCC® 27691-B1™.
