Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

2. Under anaerobic conditions, withdraw 0.5 ml of #18 from a single test tube (5 to 6 ml) and rehydrate the entire vial contents.

3. Aseptically transfer this aliquot back into the broth tube. Additional tubes may be

inoculated with 0.5 ml each from the suspension. Additionally, a slant and a plate of

4. Incubate tubes and plate under an anaerobic atmosphere at 30°C. Incubate one agar plate aerobically for aerobic contamination check. Growth on the aerobic plate should be slow with very weak growth.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

 \cdot Use of an anaerobic gas chamber, or

#18 may also be inoculated with 0.2 ml.

· Placement of test tubes under a gassing cannula system

Anaerobic conditions for incubation may be obtained by any of the following:

an anaerobic gas headspace is retained.

Notes

Minimal growth should occur on agar plate incubated aerobically. On #18 plates, colonies are circular, pinpoint, glistening, and creamy. Cells are Gram-positive non-motile rods. This organism is a facultative anaerobe. Growth can also be achieved on PYG broth.
