Handling Procedures

- 1. Open vial according to enclosed instructions.
- Using a single tube of #2107 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.

- 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
- Incubate tubes under an anaerobic atmosphere at 37°C. Incubate one agar plate anaerobically for colony formation, and one aerobically for aerobic contamination check.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber, or
- Loose screw caps on test tubes in an activated anaerobic gas pack jar

Notes

Within 24-48 hours, growth should be evident by turbidity in broth. Colonies on #260 agar are irregular, gray to white, glistening, opaque, and flat. No growth should occur on agar plates incubated aerobically. PFGE type NAP4.
