Handling Procedures

- 1. Open vial according to enclosed instructions.
- Using a single tube of #814 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.

- 4. Use several drops of the suspension to inoculate a #814 agar slant and/or plate.
- Incubate all tubes and plate at 37°C with 5% CO₂. Growth should occur in 24 to 48 hours. Assure that screw caps are loose during incubation period.
