Streptococcus pneumoniae strain 178 [Poland 23F-16] is a drug-resistant bacterium that was isolated in Poland from the broncheoalveolar lavage from a girl with a lower respiratory tract infection. This strain is serotype 23F and is a representative strain of the Poland23F-16 pneumococcal clone as confirmed by the Pneumococcal Molecular Epidemiology Network (PMEN). Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### Handling Procedures

- 1. Open vial according to enclosed instructions.
- Using a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
- 5. Incubate the tubes and plate at  $37^{\circ}$ C for 24 hours in atmosphere of 5% CO<sub>2</sub>. Loosen the screw caps during the incubation.
