Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions.

2. Using a single tube of #2 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #2 slant, and/or plate

5. Incubate the tubes and plate at the recommended temperature for 48 hours.

6. After growth has been achieved, additional transfers may be made or cells prepared for storage. Many *Vibrio* species will die off rapidly once the stationary phase is reached, even at refrigerator temperatures. To avoid frequent transfers, it is recommended that cells be frozen with a suitable cryoprotectant.

Notes

Colonies are small, entire, smooth, glistening and translucent. Cells are short slightly curved rods.
