Propagation Procedure

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

*This strain is no longer the type strain of *Proteus vulgaris*. ATCC® 29905™ is the new type strain. (See reference: *Int. J. Syst. Bacteriol.* 49:1949, 1999.)

Colonies on #18 agar are pinpoint, circular, entire, low convex, glistening, and translucent. The colonies may spread as they age.
