Propagation Procedure

1. Open vial according to enclosed instructions.
2. Using a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
5. Incubate the tubes and plate at 37°C for 24 to 48 hours.

Notes

This strain is cited to produce restriction endonuclease *NsuI* (Nucleic Acids Res 13, 1985). Colonies on #260 agar are entire, smooth, low convex, glistening and yellow. Additional information on this culture is available on the ATCC® web site at www.atcc.org.
