## Description

**Deposited Name:** *Clostridium thermoaceticum* Fontaine et al.

**Product Description:** Produces ATP synthase and acetate. Genome sequenced strain.

## Propagation

### Medium

ATCC® Medium 1203: CM4 medium

### Growth Conditions

**Temperature:** 55°C

**Atmosphere:** Anaerobic gas mixture 80% N<sub>2</sub>-10% CO<sub>2</sub>-10% H<sub>2</sub>

### Propagation Procedure

1. Open vial according to enclosed instructions.
2. Under anaerobic conditions, withdraw 0.5 mL of #1203 from a single test tube (5 to 6 mL) and rehydrate the entire vial contents.
3. Aseptically transfer this aliquot back into the broth tube. Additional tubes may be inoculated with 0.5 mL each from the suspension. Streak a blood plate to check for purity.
4. Incubate tubes under an anaerobic atmosphere at 55°C. Incubate the agar plate aerobically as a contamination check.
5. Within 48 hours, growth should be evident by turbidity in the broth. No growth should occur on agar plate incubated aerobically.

### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber.
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber.
- Loose screw caps on test tubes in an activated anaerobic gas pack jar.
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

## Notes

This strain does not readily form colonies on agar surfaces. Strain does grow in a biphasic environment on a slant.
