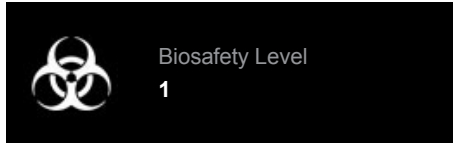

Preparation Procedure

Centrifuge tube prior to opening to prevent loss of pelleted material

1. Rehydrate contents of vial with 1 X TE or molecular grade H₂O.
2. Place vial at 37°C for 1 hour or at 4°C overnight.

Quality Control Information

1. Bacterial genomic DNA is provided in a dried form. Store at 4°C upon receipt.
2. Integrity of DNA was determined by electrophoresis on a 1% agarose gel stained with ethidium bromide, and was found to be intact and of high molecular weight.
3. No RNA was detected by electrophoresis.
