Propagation Procedure

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #44 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #44 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.
3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
4. Incubate at 37°C for 24 hours in an atmosphere of 5% CO₂.

Notes

Colonies on sheep blood agar are smooth, circular, entire, colorless, transparent, convex, and non-hemolytic. Additional information on this culture is available on the ATCC® web site at www.atcc.org.
