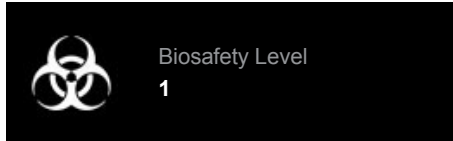

ATCC® Medium 2: Marine agar 2216 or marine broth 2216

**Growth Conditions**  
**Temperature:** 26.0°C  
**Atmosphere:** Aerobic

### Propagation Procedure

- Using a single tube of #2 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- Aseptically transfer this aliquot back into the broth tube. Mix well.
- Use several drops of the suspension to inoculate a #2 agar slant and/or plate.
- Incubate the tubes and plate at 26°C for 24-48 hours.

### Notes

Colonies on #2 agar are low convex, circular, entire, glistening, smooth, and translucent, with pink and gray pigmentation.  
Cells in # 2 broth are motile rods.

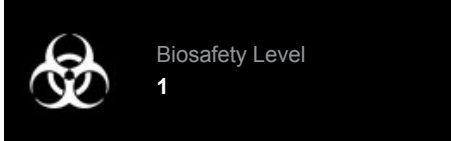
