ATCC® Medium 3: Nutrient agar or nutrient broth

### Growth Conditions

**Temperature:** 26.0°C

**Atmosphere:** Aerobic

### Propagation Procedure

- Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- Aseptically transfer this aliquot back into the broth tube. Mix well.
- Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
- Incubate the tubes and plate at 26°C for 1-2 days.

## Notes

Colonies on #3 agar appear circular, convex, entire, glistening, translucent, and yellow-pigmented.  
Cells in #3 broth are motile rods.

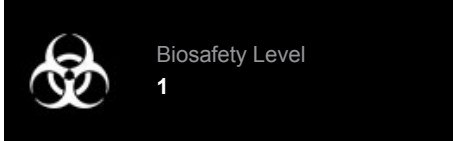
