## Propagation

### Medium

ATCC® Medium 1490: Modified chopped meat medium

ATCC® Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

### Growth Conditions

**Temperature:** 37°C

**Atmosphere:** Anaerobic gas mixture, 80% N<sub>2</sub> - 20% CO<sub>2</sub>

### Propagation Procedure

1. Open vial according to enclosed instructions.
2. Under anaerobic conditions, withdraw 0.5 mL of the recommended broth from a single test tube (5 to 6 mL) and rehydrate the vial contents.
3. Aseptically transfer this aliquot back into the broth. Additional tubes may be inoculated with 0.5 mL each from the suspension. Also, 0.1 mL may be inoculated onto a slant. Streak several blood plates to check for colonial morphology and purity.
4. Incubate tubes under an anaerobic atmosphere at 37°C. Incubate one agar plate anaerobically for colony formation, and one aerobically for aerobic contamination check.
5. In 24 to 48 hours, growth should be evident by good turbidity in the broth and by colonies on the anaerobic agar surfaces. After 24 hours, the colonies are raised, circular, undulate, large and dry. Some colonies may appear smaller and more peaked. No growth should occur on the aerobic plates.

### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

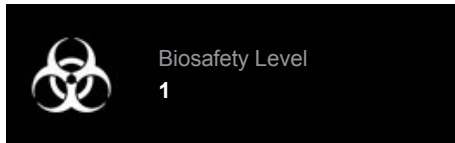
