Recommendations for Infection: Plate cells 24 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm²) diluted to provide an MOI 0.1. Adsorb for 1 hour at 37°C in a humidified 5% CO₂ atmosphere, rocking every 15 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

Incubation: 3 to 10 days

VR-1540P™ is a purified virus product suspended in Hanks Balanced Salt Solution with Ca²⁺, Mg²⁺ and 25 mM HEPES Buffer. VR-1540™ is prepared from original isolate deposited as VR-1302™, which was grown in presence of neutralizing serum to remove contaminating adenovirus type 1.

VR-1540P is a purified virus product suspended in Hank's Balanced Salt Solution with Ca²⁺, Mg²⁺ and 25 mM HEPES Buffer.
