Growth Conditions

For best results, plate cells 24-48 hours in advance. Infect at 80%-90% confluence using a multiplicity of infection (MOI) of 0.1 to 1.0. Incubate at 37.0°C in a humidified, 5% CO₂ atmosphere for 2-4 days, until CPE are well advanced in 100% of the culture. Harvest cells and culture fluids; cell debris can be removed by centrifugation if desired.

Comments

This item is a mycoplasma free preparation derived from VR-583™ following treatment to remove mycoplasma. VR-583™ will no longer be distributed when current inventory is depleted. Strain DN-19 is considered to be an antigenic variant or "prime" of Human coxsackievirus A 24. It was originally known as Echovirus 34.
