## Comments

This is a TC-adapted, attenuated TGE virus which readily produces CPE and plaques on porcine cell cultures. Preparation is contaminated with bacteria and may be filtered through a 0.2 µm filter prior to use. Titer of filtrate will decrease by approximately 1 to 2 logs.
