For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of the recommended broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Incubate the broth tube at 37°C for one week before transferring to solid medium.

5. After growth has been achieved in the broth tube, transfer culture to slants and/or plates.

1. Open vial according to enclosed instructions.

2. Using a single tube of #1395 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #173 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 7 days.

Notes

Colonies on #173 plates are entire, smooth, glistening, yellow, and vary in size under the dissecting scope.

Growth on solid medium may take 10 days or more. Colonies on #173 plates are 80% smooth, 20% rough, and pale yellow with a filamentous margin.
