Handling Procedures

1. Open vial.
2. Rehydrate the entire pellet with approximately 0.5 mL of #416 broth.

Aseptically transfer the entire contents to a 5-6 mL tube of #416 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a #416 plate and/or #416 agar slant.
4. Incubate at 37°C for 24 hours.

Notes

Results are ambiguous and we are unable to distinguish between *L. casei* and *L. paracasei* at this time.
