instructions.

- Under anaerobic conditions, aseptically transfer the entire contents to a 5-6 mL tube of #2107 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes. Best practice dictates the use of pre-reduced media.
- 3. Use several drops of the primary broth tube to inoculate a brucella blood plate plate and/or #260 agar slant.
- 4. Incubate in an anaerobic atmosphere at 37°C for 24 hours. Incubate one agar plate aerobically at 37°C to check for contamination.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

Media #1490 is an acceptable alternative media for this item.

This item may take 48 hours to recover from preservation

Anaerobe Systems Brucella Blood plate (AS-111 or AS-141) can be used to analyze colony morphology and purity.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions. Resazurin in the media is a color indicator for anaerobic conditions.

Observance of pink color in medium before use or during incubation shows anaerobic conditions have not been met and oxidation has occurred. Medium should be


