- 1. Open thawed vial according to enclosed instructions or visit www.atcc.org for instructions.
- 2. Aseptically transfer the entire contents to a 5-6 mL tube of #2263 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
- 3. Use several drops of the primary broth tube to inoculate a #2263 plate and/or #2263 agar slant.
- 4. Incubate at 37°C for 24 hours.
