Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

ATCC Medium 814: GC Agar/Broth Medium

Temperature: 37°C

Atmosphere: 95% Air, 5% CO₂

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #814 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #814 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

On #814 plates, colonies appear as a tiny pinpoint film.

This culture grows best at the broth/agar interface of the biphasic slant. To obtain a biphasic culture, add 0.4 ml of the initial suspension to a #814 slant.
