Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### **Growth Conditions**

Host: VERO C1008 [Vero 76, clone E6, Vero E6] (ATCC CRL-1586)

Effects: cell rounding; cell sloughing; CPE

**Complete medium:** 

EMEM (ATCC<sup>®</sup> 20-2003<sup>™</sup>) + 2% FBS (ATCC<sup>®</sup> 20-2020<sup>™</sup>)

Temperature: 37°C

Atmosphere: 95% Air, 5% CO2

**Recommendations for infection:** Plate cells 24-48 hours prior to infection and infect when cultures are 70-80% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.01). Adsorb 1 hour at 37°C in a humidified 5%  $CO_2$  atmosphere. End adsorption by adding virus growth medium.

**Incubation:** 5-8 days at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is progressed throughout monolayer.
