Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Complete medium:

EMEM (ATCC® 30-2003™) + 10% FBS (ATCC® 30-2020™)

Temperature: 37°C

Atmosphere: 95% Air, 5% CO₂

Recommendations for infection: Plate cells 16-24 hours prior to infection and infect when cultures are 20-40% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm²) diluted to provide an optimal MOI (e.g. 0.1). Adsorb 1-2 hours at 37°C in a humidified 5% CO₂ atmosphere. End adsorption by adding virus growth medium.

Incubation: 7 days at 37°C in a humidified 5% CO₂ atmosphere.
