Influenza A virus (H1N1) strain A/WS/33 is propagated in SPF chicken embryonated eggs. This strain was isolated in 1933 from the throat washings of a human patient with influenza. This product is whole-genome sequenced and has applications in influenza research.

Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.
