Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open the vial according to enclosed instructions.

2. Using a single tube of #329 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.



4. Use several drops of the suspension to inoculate a #329 agar slant and/or plate.

5. Incubate the tubes and plate at 26°C for 3-5 days, initial growth may take up to 10 days.
