Mouse avian erythroblastosis virus E-26 (v-ets) oncogene related :Erg was amplified using PCR from the DFCI-Mahoney 1 mouse embryonic brain library. The 0.721 kb amplified fragment was TA cloned into pCRII. The insert is not full length. Part of a set of cloned transcription factor and cofactor genes used as probes to visualize expression of TF-encoding genes in situ.
