## **Handling Procedures**

- 1. Thaw the vial at room temperature and immediately place on ice. Avoid exposing the DNA to repeated freeze-thaw cycles as it may result in degradation of the DNA and variation in copy number.
- 2. Gently mix the sample to ensure an even distribution of material.
- 3. Briefly centrifuge the tube before opening to ensure all liquid is at the bottom.

## **Quality Control Specifications**

**Total amount:** Total DNA by PicoGreen<sup>®</sup> measurement was found to be approximately 5 μg.

**Integrity:** Integrity of DNA was determined by electrophoresis on a 1% agarose gel stained with SYBR Safe<sup>™</sup>, and was found to be of high molecular weight.

**Functional tests:** Functional activity was confirmed by PCR amplification of the 16S ribosomal RNA gene.

**Identity:** Identity confirmed by sequencing of 16S ribosomal RNA gene (first ~500 base pairs).
