Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

# Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0

mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.

- 3. Transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
- 5. Incubate all tubes and plate at 37°C for 24 hours.

#### Notes

Colonies on #3 agar are entire, smooth, glistening, and circular.
