### **Handling Procedures**

- 1. Open vial according to enclosed instructions.**
- 2. From a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.**
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.**
- 4. Use several drops of this suspension to inoculate a second tube of broth, a slant, and/or a plate.**

**5. Incubate all tubes and plate at 37°C for 24 hours.**

---

**Notes**

Colonies on #44 plates have an opaque center and irregular margins. After 24 hours, the colonies begin to spread.
