Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 26°C

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube and mix well. Transfer 0.5 ml to a second broth tube and mix well. Transfers to solid media can be made from the second tube.

4. Incubate broth tubes for 24+ hours at 26°C. Incubate slants and plates at 26°C for 72 hours.

Notes

Cells are Gram negative non-motile vibroid-shaped rods, but sometimes can be filamentous. Colonies are round, slightly raised, entire and slightly umbonate.
