# **Growth Conditions**

Medium: ATCC Medium 44: Brain Heart Infusion Agar/Broth ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood Temperature: 37°C Atmosphere: Aerobic (5% CO<sub>2</sub> will enhance growth)

### Handling Procedures

1. Open vial according to enclosed instructions.



- 2. Using a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
- 5. Incubate the tubes and plate at  $37^{\circ}$ C for 24 to 48 hours. If using a 5% CO<sub>2</sub> incubator, loosen the screw caps during the incubation period.
