Escherichia coli strain B [CIP 103914, NCIB 11595, NRC 745] is a whole-genome sequenced bacterium provided in an economical preceptrol format. This product has applications in testing aerosol containment on cell sorters and it is known to produce aspartate aminotransferase.

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

This strain is used as a phage host and medium #129 is recommended for phage propagation. Colony mutants may be observed.
