Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## **Growth Conditions**

**Medium:**

ATCC Medium 38: Beef liver medium for anaerobes

**Temperature:** 37°C

**Atmosphere:** Anaerobic

## **Handling Procedures**

1. Open vial according to enclosed instructions.
- 2. Use a single tube of #38 broth (5 to 6 ml). Under anaerobic conditions, withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well. Additional tubes may be inoculated with 0.5 ml each from the suspension.**

**4. Use several drops of the suspension to inoculate a #260 agar slant and plates.**

5. Incubate the tubes and plates under anaerobic conditions at 37°C for 24 to 48 hours. An additional plate should be incubated aerobically to check for contamination.

**ANAEROBIC CONDITIONS:**

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

---

## **Notes**

Growth should be evident by turbidity in the broth and by colonies on the anaerobic agar surfaces. No growth should occur on agar plates incubated aerobically.

Colonies on #260 agar are irregular, flat, gray,  $\beta$ -hemolytic, and spread over time.
