Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Medium:

ATCC Medium 129: Nutrient agar/stabs/broth with 0.5% NaCl

Temperature: 37°C

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #129 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #129 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 24-48 hours.

1. Open vial according to enclosed instructions.

2. From a single tube of #129 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.

3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.

4. Incubate the tube at 37°C for 24 hours.

5. After growth has been achieved, use several drops of the suspension to inoculate an additional broth tube, a #129 agar slant and/or a plate.

Notes

Colonies on #129 agar appear entire, smooth, low convex, and opaque.

Growth on solid medium may be slightly delayed on initial subculture. Transfer grown broth culture to additional slants or plates. Colonies are entire, glistening, smooth, translucent, and gray. This strain will also grow on most routine media; the #129 medium is used for phage production.
