## Growth Conditions

### Medium:

Anaerobe Systems Brucella Blood Agar Plates (BRU) (AS-111 or AS-141)

ATCC Medium 5608: PY Medium (M2-VPI) With D-Glucose w/ Durham Tube

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

**Temperature:** 37°C

**Atmosphere:** Anaerobic

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Under anaerobic conditions, withdraw 0.5 mL of #5608 broth from a single test tube (5 to 6 mL), with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a pre-reduced Brucella blood plate and a #260 slant. An aerobic blood plate may also be streaked to check for purity.
5. Incubate the tubes and plate under anaerobic conditions at 37°C for 24 to 48 hours. Incubate the purity plate aerobically at 37°C. Turbid growth is evident in the broth at 24 to 48 hours.

### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber.
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Aerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar.
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

### Notes

Anaerobe Systems PRAS Brucella Blood Plates (AS-111 or AS-141) can be used to analyze colony morphology and purity.

Colonies on Brucella Blood agar are slightly irregular, low convex, gray and  $\beta$ -hemolytic.
