Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
 5. Incubate the tubes and plate at 37°C for 24 to 48 hours.

Notes

Two colony types are observed on #18 agar. One colony type is large, translucent, flat, and irregular. A second colony type is small, circular, flat and opaque.

ATCC Medium #3 may also be used to culture this strain.
