ATCC Medium 44: Brain Heart Infusion Agar/Broth

**Temperature:** 37°C

## Handling Procedures

1. Under anaerobic conditions, withdraw 0.5 mL of #44 from a single test tube (5 to 6 mL) and re-hydrate the entire vial contents.
2. Aseptically transfer this aliquot back into the broth tube. Additional tubes may be inoculated with 0.5 mL each from the suspension. A slant of #44 may also be

inoculated with 0.2 mL. Streak several plates to check for colonial morphology and purity.

3. Incubate tubes under an anaerobic atmosphere at 37°C. Incubate one agar plate anaerobically for colony formation and one aerobically for aerobic contamination check.
4. Incubate the tubes and plate at 37°C for 48 to 72 hours.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber.
- Placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber.
- Loose screw caps on test tubes in an activated anaerobic gas pack jar.
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

## Notes

This item can also be grown very effectively on chopped meat medium under 5% CO<sub>2</sub>

.
