*Streptococcus pyogenes* typing strain T1 [NCIB 11841, SF 130] is a whole-genome sequenced bacterial type strain. The culture is in Lancefield's group A (Group A Streptococcus; GAS) and has applications in bioinformatics, media testing, and infectious disease research.

## **Handling Procedures**

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
  2. Rehydrate the entire pellet with approximately 0.5 mL of #44 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #44 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
  3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
  4. Incubate at 37°C for 24 hours.
