Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.

Notes

Colonies on #260 plates are entire, glistening, smooth, opaque, gray, and exhibit b-hemolysis.
