Temperature: 37°C

Handling Procedures

1. Open vial according to enclosed instructions.
 - 2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
 - 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
 - 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.**
 5. Incubate the tubes and plate at 37°C for 24-48 hours.

Notes

Two colony types observed on #260 agar plates are a) small, entire, glistening, circular, smooth, and pulvinate; and b) entire, glistening, circular, smooth, and low convex. Both types exhibit β -hemolysis and Lancefields Group A.
