### **Medium:**

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

**Temperature:** 37°C

## **Handling Procedures**

- 1. Open vial according to enclosed instructions.**
- 2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
- 4. Use several drops of the suspension to inoculate #260 slant and/or plate.**

## **5. Incubate all tubes and plates at 37°C for 24 hours.**

### **Notes**

Colonies on #260 plates are entire, smooth, circular, glistening, and exhibit beta-hemolysis.
