Streptococcus dysgalactiae subsp. *equisimilis* grouping strain C74 is a whole-genome sequenced strain that was isolated from a throat culture. The culture was deposited by RC Lancefield and has application as a control strain for Group C *Streptococcus* (GCS).

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

This strain was deposited as *Streptococcus* sp. and later changed to *Streptococcus equisimilis* before it was changed to its current name *Streptococcus dysgalactiae* subsp. *equisimilis*.

This strain will also grow on Brain Heart Infusion Agar (BD 241830).
