## Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #416 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well



- 4. Use several drops of this suspension to inoculate a second tube of broth, a slant and/or a plate.
- 5. Incubate tubes and plate at  $37^{\circ}\text{C}$  in an atmosphere of 5% CO<sub>2</sub> for 24 to 48 hours. Caps should be loose.

#### Notes

Colonies on plates are small, round, smooth, entire, glistening, and convex.
