will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

Frozen ampules packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampules at refrigerator freezer temperatures (generally -20°C).** Storage of frozen material at this temperature will result in the death of the culture.

1. To thaw a frozen ampule, aseptically add 0.5 ml fresh ATCC medium 351 broth to

the frozen pellet, then place the ampule in a 35°C water bath until thawed (2-3 min). Immerse the ampule just sufficiently to cover the frozen material. Do not agitate the ampule.

2. Immediately after thawing, aseptically transfer the entire contents to a single 16 x 125 mm screw-capped test tube containing 5 ml of ATCC medium 351 broth.

Incubate the tube upright for one hour at 25°C.

3. Gently remove as much supernatant as possible (the methanol cryoprotectant can inhibit growth) and refill with an equal volume of fresh broth medium.

4. Incubate on a horizontal slant at 50-100 $\mu\text{Einsteins}/\text{m}^2/\text{s}$ irradiance at 25°C with the cap loosened one half turn. Maintain under a 14/10 h light-dark photoperiod.

Culture maintenance:

1. Inoculate a tube of fresh broth medium with 0.2 ml from a growing culture at or near peak density.

2. Incubate on a horizontal slant at 50-100 $\mu\text{Einsteins}/\text{m}^2/\text{s}$ irradiance at 25°C with the cap loosened one half turn. Maintain under a 14/10 h light-dark photoperiod.
